

How do I setup printing from my iPad?

In DrChrono you have the option to print from anywhere you see the menu icon (



) in the top right of your iPad.

To do this you will need to use an Airprint-compatible printer. You will need to set this up outside of your DrChrono app. To do this please go [here](#) and it will take you through the steps to set up printing from your iPad.

Please make sure you are also using our most [up-to-date software](#) by going to the App Store on your iPad and checking for updates.
