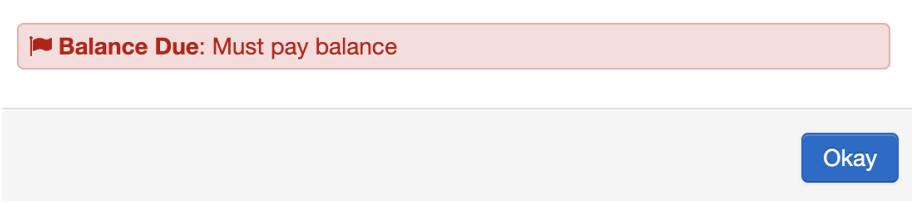

Note: The Patient Flag Alerts feature is being enabled for customers over the next month. All accounts will have this feature by mid-February.

Patient Flag Alerts can be set up so that designated flags will pop up for patients or appointments that have been assigned those flags.

For example, if the patient has a balance due, you can set it up so that a Balance Due flag pops up for the patient.
